The Board is pleased to announce that the Proposed Acquisition was completed on 22 October 2024. The Company has nominated its wholly-owned subsidiary, Embracing Future E-Sports Pte. Ltd., to hold the Equity Interest, which represents 100% of the registered capital of the Target Company.

The Company will make further announcements as appropriate to update Shareholders on the achievement of the NPAT Target, which will be determined within four months from the end of the Earn-Out Period, which is the 12-month period commencing the day of Acquisition Completion to the first anniversary of Acquisition Completion (both days inclusive). A special audit will be performed to audit the management accounts of the Target Company in respect of the Earn-Out Period.
